WELL IF IT IS THEIR PRODUCTS YES I KNOW

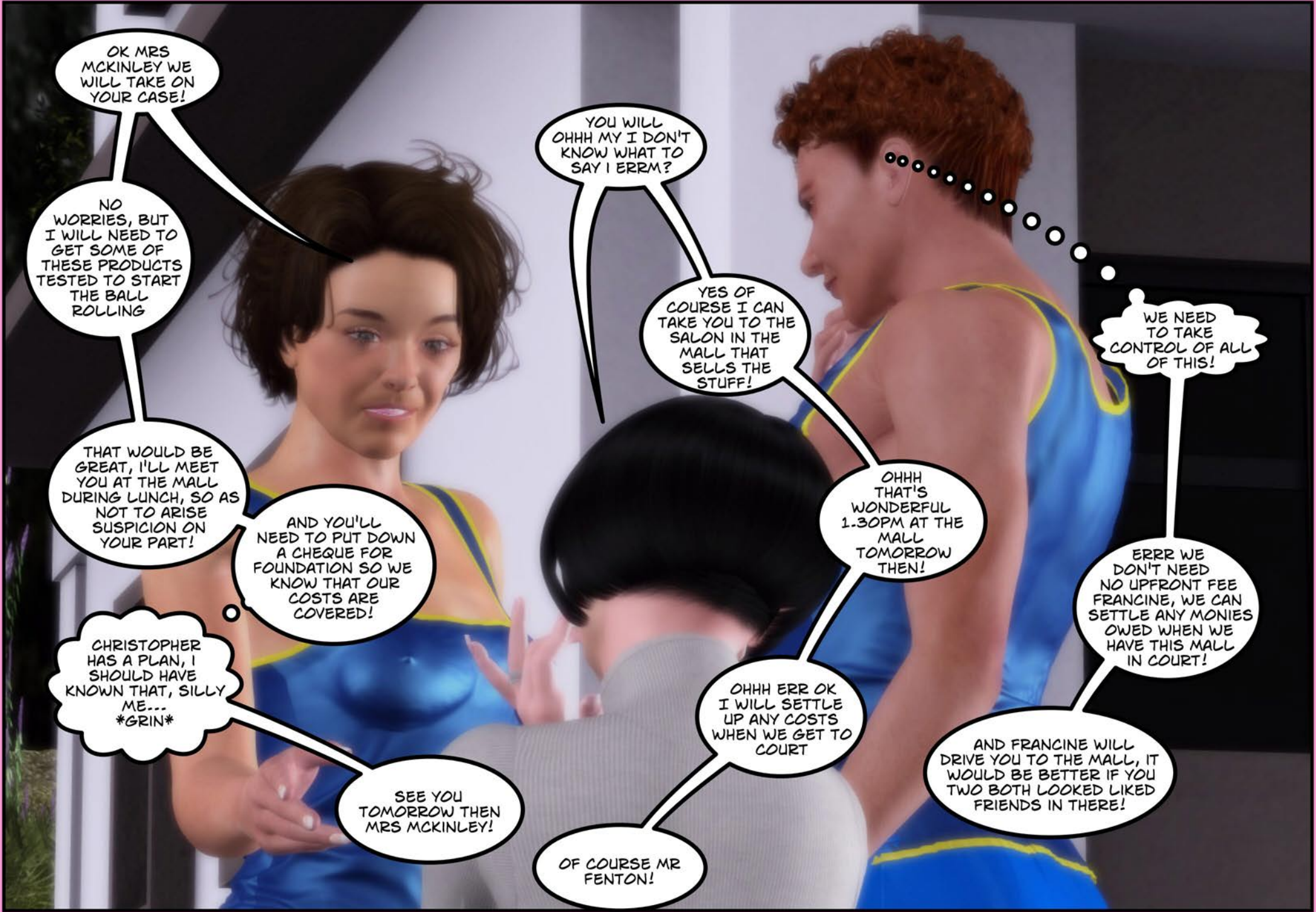

OH I HAVE NO DOUBT WHAT SHE SAYS ABOUT THE PRODUCTS BEING RUBBISH



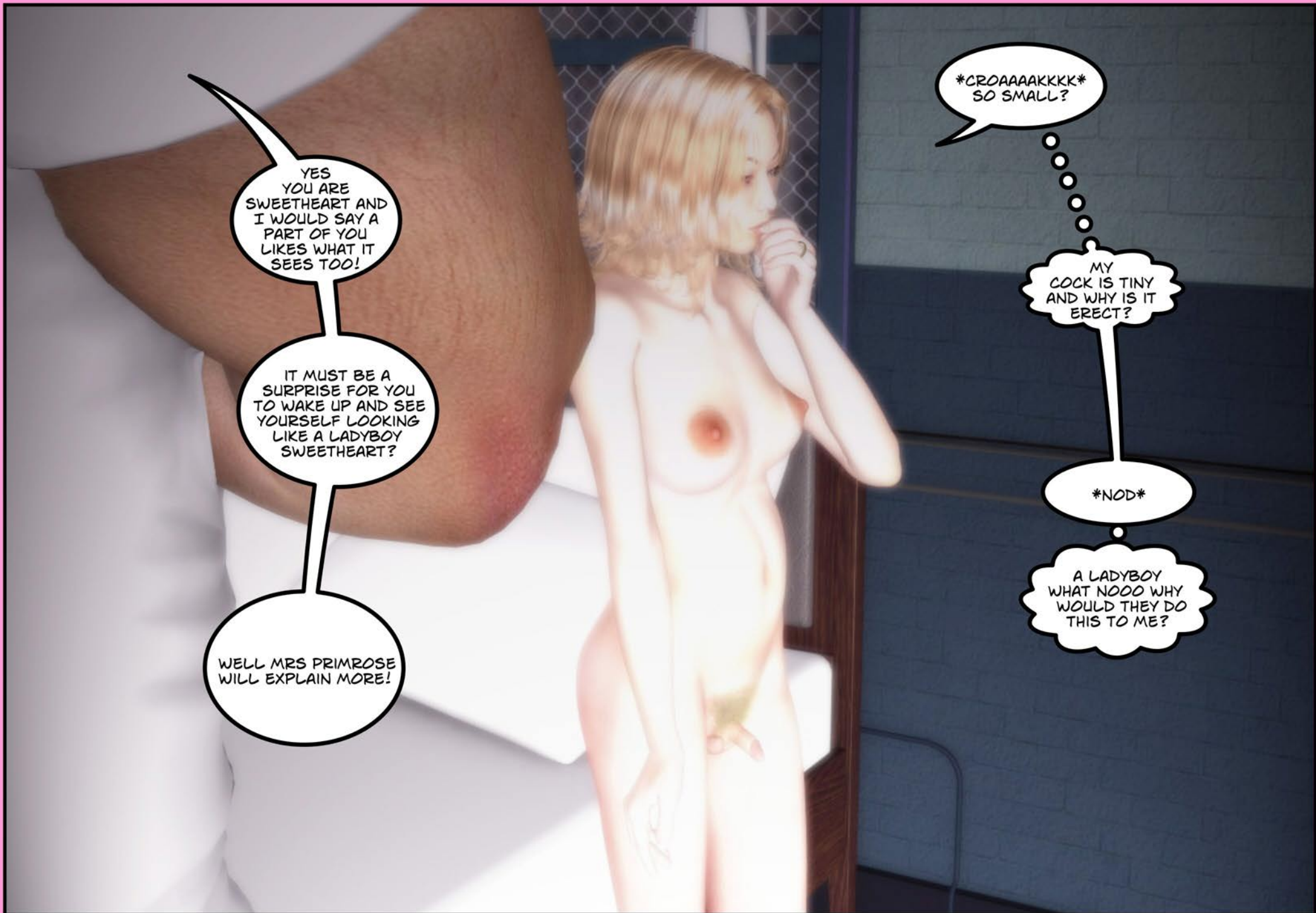
